The Directors of Comodo CA Ltd are responsible for establishing and maintaining effective controls over its CA operations, including CA business practices disclosure in its **Certification Practice Statement** on its website, service integrity (including key and certificate life cycle management controls), and CA environmental controls. These controls contain monitoring mechanisms, and actions are taken to correct deficiencies identified.

There are inherent limitations in any controls, including the possibility of human error and the circumvention or overriding of controls. Accordingly, even effective controls can provide only reasonable assurance with respect to Comodo CA Ltd's Certification Authority operations.
